The law school requires differential tuition to pay for its cost of instruction. This review seeks to continue the law school's well established differential tuition for its Juris Doctor (JD) program at the same level that has been in effect since the 2012-13 academic year.

The law school's JD program offers a professional degree and competes in more expensive regional and national markets that require more resources to remain competitive, including the ability to attract faculty who demand higher salaries.

The tuition differential supports the school's curriculum, which provides students with experiential learning opportunities and requires a low student:faculty ratio. This ratio is important to the school's nationally ranked Law Clinic, which is required for all JD students. Very few law schools have a clinic requirement.

The law school's JD program is geared toward meeting licensure requirements. In September 2020, 86% of our JD graduates passed the NM Bar Exam on their first attempt, which compares very favorably with graduates of other regional and national law schools.

The law school's JD curriculum is weighted toward required courses rather than elective courses. The entire first year consists of required courses, and students must take additional required courses thereafter.



The law school's higher tuition is justified because the program necessitates expenditures above those required for typical graduate programs of instruction, and beyond the level of additional support available from class and curricular fees alone. Those higher expenditures consistently yield outstanding results because UNM JD graduates outpace national rates in employment outcomes.

Please provide a detailed explanation on how the revenue is used for this program:

A majority of differential funds support faculty expense in order to maintain the law school's low faculty:student ratio. This essential ratio facilitates the law school's exemplary doctrinal- and experiential-learning curriculum.

Operating funds are spent on the law school's various student support services (e.g., Student & Career Services, Admissions/Financial Aid, Registrar, Law Library, and IT) and academic programs (Law and Indigenous People's Program, Natural Resources and Environmental Law Program, Madrid Summer Law Institute, Tribal Law Journal). A small portion is used for facilities maintenance as well.

Differential tuition also funds personnel for the Admissions/Financial Aid Office, Registrar, Student Employment Support Staff, and Law Clinic Support Staff.

Student Access and Affordability: Please explain how student access and affordability has been addressed.

UNM School of Law is one of the most affordable law schools in the Mountain West Region and in the country. Each year, the National Jurist/ PreLaw Magazine ranks law schools on overall value, which is calculated based on total tuition expense, cost of living, average indebtedness after law school, bar passage rate, and employment success. UNM School of Law regularly ranks in the top 25 best value law schools in the country.

Tuition for New Mexico residents at our school has always been dramatically lower than private law schools and significantly lower than resident tuition most other law schools. Current annual resident tuition is \$18,938, including all law school fees paid by students, which is \$8,533 below the FY 2021 projected peer median resident tuition of \$27,471. Current annual non-resident tuition is \$39,890, which is the FY 2021 projected peer median. See Attachments A and B. Many non-residents qualify for the resident rate in their second and third years. Law school alumni and friends provide support for more student aid than ever before, while University support allows the law school to maintain its low tuition.



Our affordability is a big factor for applicants. Many students choose UNM not only because of our great academic programs and employment outcomes, but also for our incredible value. Applicants are smart consumers who are very conscious of the cost and overall value of their degree.

The law school awarded over \$1.4 million in scholarships to its 310 JD students, which helps to reduce their debt upon graduation. These scholarships include programs and funds that target historically disadvantaged communities including American Indian and Alaska Native students, which help to remove financial barriers that otherwise might prevent these students from attending law school. These scholarships and our remarkably affordable tuition allow these students and others to complete law school and serve their communities around New Mexico.

Our JD graduates enjoy one of the lowest debt loads among our regional competitors. Indeed, the average loan indebtedness for three years of law school in the class of 2019 was \$83,885 which is among the lowest figures in the region by several thousand dollars. Lower debt gives our graduates the financial latititude to enter the workforce at a wide range of starting salaries, which allows them to provide desperately needed legal services in the private, public, and public interest sectors. For example, of the graduates in the class of 2019 employed as of March 15, 2020, 40.22% were in private practice, 39.07% were in the public sector (26.43% government and 12.64% judicial clerkships), and 9.20% were in the public interest sector. The remainder were in business (5.75%) and unknown employer type (5.75%). 93.5% of those graduates accepted jobs in New Mexico.
