The UndocuTask Force is <u>charged with</u> strengthening resources and support services for these students by establishing a formal network of internal units and community partners.

Higher Learning Commission Letter

Last week President Abdallah sent <u>a message to campus</u> describing <u>a letter</u> that The University of New Mexico received from our regional accreditor, the Higher Learning Commission. The letter contained a request for a report about an audit by the New Mexico State Auditor. We are preparing that report presently, and will respond to the HLC by the required submission date of September 14, 2017.

I encourage you to read the <u>president's message</u> in full. The report will allow us to show that the University is financially sound, as demonstrated by annual independent audits, and the recent

reaffirmation of our bond rating, among other evidence. For more information on these topics, as well as the impact of these practices on UNM's accreditation, we put together <u>a FAQ</u> to clarify the issues.
