I. Call to Order

Regent Hosmer called the meeting to order at 1:04 p.m.

II. Approval of Summarized Minutes from Previous Meeting: (December 5, 2013)

Motion for approval of the minutes was made by Provost Chaouki Abdallah, seconded by Regent Suzanne Quillen. Motion passed unanimously.

III. Reports/Comments:

A. Provost's Administrative Report Chaouki Abdallah, Provost and Executive Vice President for Academic Affairs

Robert Wood Johnson Foundation is closing 10 sub-centers including one here at UNM and one at HSC. It will take 5 years to close. A discussion will occur on these plans. This is a big loss for UNM.

Report on active searches: Dean of Libraries Good pool of finalists.

Anderson School of Management Dean

Committee has recommended 4 candidates who will visit the campus.

College of Education

The search has been extended to mid-March. There are some strong candidates for this position.

A meeting was held with CNM to discuss initiatives to facilitate transfer of students and that UNM is moving away from IS courses. UNM is going to start an Early Start and Stretch program rather than IS courses. There will be no remedial English courses scheduled in the fall. Both UNM and CNM will be sharing data and designing a path for the success of students whether they start at CNM or UNM. B. Member and Advisor Comments

Faculty Senate

Faculty Senate passed the policy that lowers the hourly requirement for baccalaureate degrees from 128 to 120. Disciplines will be encouraged to view their curriculums.

Faculty in interested in the Innovate ABQ, more specifically the academic portion and is most interested in Innovation Academy.

Faculty salaries continue to be an issue. As the economy seems to be improving nationally, it is important that the university recognize this and investigate salary increases for faculty.

GPSA

President Poliana reports that joint work with ASUNM for the university to develop a new user friendly online billing platform.

GPSA is re-branding and office renovation. A new logo is being created.

A. STEM Up Grants

The STEM UP grant is a Title V grant funded for five years in the amount of \$3,473,005 by the Department of Education and authorized under Title III, Part F, Section 371 of the Higher Education Act of 1965 as amended, Hispanic Serving Institutions (HSI) STEM and Articulation Program Cooperative

GOALS:

- 1) Increase the number of Hispanic and/or low-income students attaining degrees in the fields of science, technology, engineering or mathematics
- 2) Develop model transfer and articulation agreements between two year Hispanic Serving Institutions (HSI) and 4 year institutions in such fields

STEM Gateway

Funded by the US Department of Education Hispanic serving institutions Recently completed second year of a five year program Four main components Course Reform – faculty led reform projects Peer Learning Facilitators – undergraduate students placed large lecture classrooms. Imbedded tutors collaborating with instructors to provide active learning opportunities. Program Courses- specially designed seminar courses that assist pre-STEM students prepare for their degree programs. Research – institutional research projects into the STEM student experience.

Of all STEM bachelor's degree earners in 2010-11, 41% completed at least one pre-calculus mathematic course at UNM.

OVPR Website - During the Fall 2013 semester a working group was formed to review and develop a new OVPR website. The site is now being reviewed by constituent groups and should be fully deployed by February 1, 2014. Sandia Lab/UNM Joint Hire - The Joint Search Committee has completed interviews with 3 finalists for the joint hire opportunity in Materials Science & Engineering.

Office of Sponsored Projects - Office of Sponsored Projects (OSP) has a new director and organizational structure. The staff has been organized by teams assigned to various campus units and the contract negotiation process has been streamlined.

Main Campus Compliance Office - The Main Campus compliance office is now fully consolidated (IRB, COI, Export Control, and Industrial Security). In particular, the IRB function has now fully transitioned back to on Main Campus. Proposal processing greatly reduced: now under 30 days for full review. Currently awaiting new software implementation (IRBnet). Due in early March.

Research Retreat - The OVPR hosted a productive retreat with the ADR/CD, its advisory committee (which consists of Associate Deans of Research, Center Directors, and Faculty Senate Research Policy Committee). The retreat resulted in a new cost recovery distribution model.

Research Collaboration - Good progress has been on the development of the New Mexico Collaborative Research and Development Council. The next steps are getting the three working groups together (leadership, contracts/grants and researchers) this Spring. Endowed Chairs - Carlos Romero is working with UNM chairs and deans in response to Governor Martinez' endowed chair initiative.
